GENERAL INFORMATION/POLICIES AND PROCEDURES

- INSTRUCTORS:** Most are independent contractors or volunteers; curriculum is their responsibility and learning rests with the teacher/facilitator and students.
- REGISTRATION FEES:** Registration fees allow us to maintain Groton's historic building as well to offer diverse classes, educational workshops and special events. Your support of the Prescott School Community Center (PSCC) through registration is greatly appreciated! If a class is cancelled, your registration fee will be refunded.
- CLASS LOCATION:** All classes to be held at the Prescott Center, 145 Main Street, unless otherwise noted in the class description.
- HOLIDAYS, CANCELLATIONS, MAKE UP CLASSES:** Classes are not held on legal holidays except where noted. PSCC reserves the right to cancel any course with insufficient enrollment within 5 days prior to the first date of the class offering. In the event of a class cancellation or make-up class we notify participants using phone numbers or emails provided to us. To avoid cancellations, we urge registrations be completed 7 days before the start date of a class.
- REFUND POLICY:** Registration Fee of \$5.00 is non-refundable unless all courses on registration form are cancelled. There are no refunds on withdrawals once a class has begun. In the event your class is cancelled due to low enrollment you will receive a full refund. PSCC reserves the right to change the program location and/or programming staff if needed. Refunds will not be given if this occurs.
- SNOW DAYS:** PSCC follows snow day cancellations/announcements, unless we notify you otherwise, of the Groton Dunstable Regional School District for DAY CLASSES. Evening classes may be held on GDRSD Snow Days. No delayed classes on GDRSD delayed openings. Check www.prescottscc.org for announcements. Make-ups for classes cancelled due to weather are coordinated by facilitator.
- CLASS WITHDRAWALS:** No refunds will be made for withdrawals once a class has begun.
